SCHEDULE A - REGULATIONS

CARNEYS POINT TOWNSHIP RECREATION COMMISSION

303 Harding Highway
Carneys Point, NJ 08069

No person or group of persons while in or upon any public parks, playground or recreational area of the Township shall:

1. Be in or upon any public park, playground or recreational area for any purpose during the hours of closing for said areas are established by Resolution of the Township Committee, except authorized person while in the performance of official duties.
2. Damage, deface, injure, destroy, displace or remove any buildings, tables, benches, fireplace, paving, signs, notices, monuments, trees, shrubs, plants, stakes, boundary markers, utilities or other structures or equipment, facilities or appurtenances whatsoever, unless in the maintenance of said property by authorized personnel.
3. Construct or erect any tent, building, or other structure of whatever kind, whether permanent or temporary, or run or strung lines, wires or other lines upon or across such lands, unless upon special written permission issued by the Township Committee.
4. Hunt, pursue, shoot, harm, trap or kill any animal or wildlife found upon such lands.
5. Bring or dump upon, deposit or leave any bottles, broken glass, trash, garbage or other refuse except in connection with the proper use of the property and placed in the proper receptacles where provided for such matter; and where receptacles are not provided, such matters shall be carried away by the person responsible for its presence and properly disposed of elsewhere.
6. Drive or park any vehicle on any area except the roadways or parking areas provided, or such areas as may be authorized attendant who may be present.
7. Leave a vehicle or bicycle standing or parked thereon in any areas during the hours when the property is otherwise closed.
8. Operate a vehicle or bicycle in a careless manner.
9. Swim, bathe or wade in any waters in or adjacent to any such lands except in such areas as are provided for that purpose.
10. Dress or undress in any vehicle or other place except in such areas as are provided for that purpose.
11. Fish in any waters or from any area restricted therefrom by proper authority.
12. No person shall carry or possess firearms of any description, bows and arrows, or other forms of weapons or trapping device inimical to wildlife or dangerous to human safety. Shooting into such land areas from beyond their bounds is strictly prohibited.
13. Picnic or lunch in a place other than those designed for that purpose or unduly delay or prevent the use of such permitted areas by others.
14. Create a fire except in connection with food preparation in approved fireplaces or receptacles designated or provided for such purpose; nor leave a picnic area before the fire is completely extinguished and all shall be carried away by the user to be properly disposed of elsewhere.
15. Set up a tent, shelter or other temporary device or vehicle for overnight camping, nor leave any structure or vehicle that could be used for such purpose thereon during closing hours.
16. Play any game involving the throwing or flying of objects except in places provided for such recreation.
