

**INDUSTRIAL COMMISSION OF  
CARNEYS POINT TOWNSHIP  
MEETING MINUTES  
JULY 08, 2013**

The meeting of the Carneys Point Industrial Commission was held on the above date at the time of **6:50 p.m.** Commission members Johnson, Pennington, Racite and Redfield were present. Mr. Bomba, and Mr. O'Donald were not in attendance. Also present was J. Proffitt-Secretary.

Mrs. Racite called the meeting to order; read the **Open Public Meeting Act** and led the **Salute to the Flag**. **Roll call** was taken and a Quorum was established.

Mr. Redfield motioned to approve **minutes** from the **June 10, 2013** Industrial Commission meeting, seconded by Ms. Pennington and all were in favor.

Under **Old Business**, the Committee took a few moments to review the video from Cory Sickles of Burning Image. Mr. Sickles said he was unable to get business owners to agree to be put on tape. The Commission liked the overall video but was not sure of the interview with Assemblywoman Celeste Riley. Ms. Pennington said she was flat and not did not seem enthused about Carneys Point. Mayor Gatanis said Assemblyman John Burzichelli would have been a better choice. The Mayor said he could make a phone call to set up an appointment for an interview. The Mayor also asked why was Freeholder Bob Vanderslice used for the video and not Freeholder Chairperson Julie Action. Mr. Sickles said she was almost impossible to make an appointment with and Mr. Vanderslice is overseeing the County Economic Development. Mr. Redfield asked if there were any other interviews available to view. Mr. Sickles said they were parts and pieces, nothing coherent or what they said was said better by someone else. The Mayor said he would like to see some of the construction put on the video showing the Township is moving forward and growing. Mr. Sickles said he can take video of the housing construction site and work it in the video. Mr. Redfield asked how long does the video play. Mr. Sickles said about six minutes. Mr. Redfield said it was about to lose his interest based on the time. Mrs. Racite made the same comment. Mr. Sickles said he can shave about 15 seconds off. Mr. Sickles said this is a working draft copy and this is what he is looking for. He wants reactions and comments. He will go back and will try to set an appointment with Burzichelli, also work  
In the new housing construction sites.


Mrs. Racite addressed the marketing of the video. Mr. Sickles said u-tube, e-mail, on your website and hand out copies. This will be your disc and you will be able to make copies. Mr. Sickles said the video still needs a website and phone contact. That was discussed as some length. With all comments made Mr. Sickles left the meeting.

With no **Correspondence** or New Business to report Mrs. Racite moved on to ask for a motion to approve the bill list. Motion was made by Ms. Pennington, seconded by Ms. Johnson and all were in favor.

Mrs. Racite opened the meeting up for **Public participation**. Dave Wright of Golfwood Ave. said he would have liked the use of a wider lens when the pictures of the Township were taken. This would have allowed people to see more details of the area. He commented that some of the pictures could have been anywhere. With no more public questions or comments this portion was closed.

With no further business to discuss, a motion was made by Mr. Redfield, seconded by Ms. Johnson to adjourn. Motion passed with four affirmative votes. Meeting adjourned at 7:28 pm.
